XTREMCOIN WEBSITE RISK WARNING

This Xtremcoin Website Risk Warning ("*Risk Warning*") has been prepared for the purpose of warning Website User and Visitors about the current and potential risks of cryptocurrency transactions and investments executed through the website www.xtremcoin.com ("*Xtremcoin Platform*"; "*Website*") which is operated by Geliyoo Bilişim Araştırma Geliştirme Sanayi ve Ticaret Limited Şirketi ("*Xtremcoin*") located at Büyükdere Caddesi Yapı Kredi Plaza C Blok No:40-41 Kat:17 Ofis No: DO-01 Levent, Beşiktaş, Istanbul, 34330 and registered to Istanbul Chamber of Commerce with the registration number 898925.

Price Risk

The exchange of Cryptocurrency, like the other areas of trade, also carries significant risks. The values/prices of cryptocurrencies are fluctuating every other day. The exchange of Cryptocurrency is sensitive to irrational or rational information and loss of confidence. It is possible that the Cryptocurrency values increase or decrease at very high rates during the same day; even it means big potential gains, on the other hand, also might mean big potential loses.

Since the Cryptocurrency is not governed by a central authority, the value of the Cryptocurrency is based on the principle of trust; therefore, many reasons such as unexpected changes, a government restriction, competition from alternative currencies may suddenly reduce the value of Cryptocurrency.

Security and Risks of the System

The User or Visitor must ensure that it has entered the Website by using a secure computer. Otherwise, if the User Account is accessed through an unsecure computer, the Account has risks of exposure to cyberattacks and Cryptocurrencies have risks of theft. The User makes a decision by taking this important issue into consideration while executing transactions. Xtremcoin cannot be held responsible for the matters that are irrevocable and arise from the nature of the blockchain.
